TRADEMARK ASSIGNMENT

NOW THEREFORE, in consideration of the Purchase Price paid by Assignee to Assignor under the Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment. Assignor hereby confirms that Assignor has sold, assigned and transferred and by these presents does sell, assign and transfer unto Assignee, its successors and assigns, all of Assignor’s right, title and interest in and to the Trademark, including the registration and all documentation therefor, together with all goodwill attached to the Trademark, and all right of action resulting from any adverse use of the Trademark or any confusingly similar trademarks and the right to claim such relief as is appropriate, the same to be held by Assignee, its successors and assigns as fully and effectively as they would have been held by Assignor had this sale, assignment and transfer not been made.


