Assignor is the owner of the trademark and trademark registration identified on Schedule A, including the goodwill connected with the use of, and symbolized by, said trademark; and



In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


