**RELEASE OF SECURITY INTEREST
IN SECOND LIEN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of June 8, 2017, is made by Cortland Capital Market Services LLC, in its capacity as successor administrative agent and collateral agent for the secured parties (as defined in the Assignment and Assumption of Second Lien Intellectual Property Security Agreement referred to below (the "Agent"). Capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, the Second Lien Pledge and Security Agreement or the Assignment and Assumption of Second Lien Intellectual Property Security Agreement, as applicable.

WHEREAS, in connection with that certain Second Lien Credit Agreement, dated as of December 20, 2012 (as amended, restated, supplemented or otherwise modified from time to time) (the "Second Lien Credit Agreement"), among Washington Inventory Service, a California corporation ("Borrower"), the other entities party thereto as Loan Parties, the Lenders from time to time party thereto, the Agent (as successor-in-interest to Antares Capital LP) and the other parties party thereto, credit extensions were made to the Loan Parties;

WHEREAS, in connection with that certain Second Lien Pledge and Security Agreement, dated as of December 20, 2012 (as amended, restated, supplemented or otherwise modified from time to time) (the "Second Lien Pledge and Security Agreement"), among the Agent and the Grantors party thereto, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "Security Agreements"), Western Inventory Service and WIS International, Inc. as the grantors (collectively, the "Grantors") granted security interests in certain intellectual property including those listed on Annex I attached hereto (collectively, the "Intellectual Property Collateral");

WHEREAS, in connection with that certain Agency Assignment and Acceptance Agreement dated as of August 12, 2016, by and among Antares Capital LP, as Assignor, and Agent, as Assignee, Assignor assigned to Assignee its rights, powers, privileges, responsibilities, duties and obligations as administrative agent and collateral agent under the Second Lien Credit Agreement, the Second Lien Pledge and Security Agreement, the Security Agreements and the other Security Documents and other Transaction documents, subject to the terms of the 2016 assignment; and

WHEREAS, the Security Agreements were recorded in the USPTO on the dates and on the reel and frame numbers set forth on Annex I hereto.

NOW THEREFORE, the Agent hereby RELEASES, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Second Lien Credit Agreement or the Second Lien Pledge and Security Agreement, and Agent hereby reassigns any and all such right, title and interest (if any) that Agent may have in the Intellectual Property Collateral to the Grantors.


