## AGREEMENT TO ASSIGN TRADEMARKS

**WHEREAS**, LAND VIEW wishes to assign the above listed Applications to NATIVE EARTH in accordance with the terms and conditions of this Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and the mutual covenants specified herein, the parties, intending to be bound legally, agree as follows:

1. LAND VIEW hereby acknowledges the transfer all of its assets, rights, obligations, in the business known as Native Earth to NATIVE EARTH, LLC as of January 1, 2017.

2. LAND VIEW, as assignor, does hereby assign to NATIVE EARTH the Applications listed above, together with the goodwill of the business symbolized by the mark and the brands lists.

3. The Applications are being assigned as part of the entire business to which the mark pertains as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060.

4. For each Application, NATIVE EARTH shall develop the market and brand and then file an Allegation of Use for each name or brand in actual use in commerce.

5. NATIVE EARTH shall be solely responsible for filing any extensions of time to file a Statement of Use, as necessary.

6. This Agreement shall be binding upon and inure to the benefit of the parties, and their successors and assigns.

In consideration of the foregoing, the parties have each caused this Agreement to Assign Trademarks to be signed (by their respective duly authorized officers or representatives) on the dates set forth adjacent to their respective signatures.
