**DECLARATION OF MORGAN TAYLOR IN SUPPORT OF REQUEST FOR
CORRECTIVE TRADEMARK ASSIGNMENT**


I, Morgan Taylor, declare as follows:

1. I am currently the President of Taylor Brands, LLC. I make this declaration based on my personal knowledge of the facts set forth herein, except where otherwise indicated.
2. On April 13, 2010, Taylor Brands, LLC assigned to Wyoming West Designs II, Inc. all right, title, and interest in and to the marks COWBOY UP (Reg. No. 3,455,083) and COWGIRL UP (Reg. No. 3,455,084) together with the goodwill of the business symbolized by said marks (the "2010 Assignment"). A copy of the 2010 Assignment is attached hereto as **Exhibit 1**.
3. The 2010 Assignment was recorded with the U.S. Patent and Trademark Office on April 22, 2010 at Reel 4190, Frame 0861.
4. At the time of the 2010 Assignment, I was President of Taylor Brands, LLC.
5. On August 1, 2016, Taylor Brands, LLC assigned all trademarks owned by it together with the goodwill of the business symbolized by the marks to BTI Tools, LLC as part of a larger corporate transaction (the "2016 Assignment"). However, the 2016 Assignment inadvertently and mistakenly included the COWBOY UP (Reg. No. 3,455,083) and COWGIRL UP (Reg. No. 3,455,084) trademark registrations that Taylor Brands, LLC previously assigned to Wyoming West Design II, Inc. on April 13, 2010. The 2016 Assignment was recorded with the U.S. Patent and Trademark Office on August 12, 2016 at Reel 5854, Frame 0211.
7. Pursuant to TMEP § 503.06(C), to the extent that the 2016 Assignment included the trademark registrations for the COWBOY UP and COWGIRL UP marks, that portion of the assignment was not proper because Taylor Brands, LLC did not own those two trademark registrations at the time of the 2016 Assignment of trademarks to BTI Tools, LLC.
8. I am advised that after Taylor Brands, LLC assigned all of its rights in the COWBOY UP (Reg. No. 3,455,083) and COWGIRL UP (Reg. No. 3,455,084) trademark registrations to Wyoming West Designs II, Inc. in the 2010 Assignment, two subsequent assignments/security interests were recorded with the U.S. Patent and Trademark Office concerning these trademarks. On July 29, 2016, Wyoming West Designs II, Inc. assigned to Sidran, LLC, all right, title, and interest in and to the marks COWBOY UP (Reg. No. 3,455,083) and COWGIRL UP (Reg. No. 3,455,084) together with the goodwill of the business symbolized by said marks. The July 29, 2016 Assignment was recorded with the U.S. Patent and Trademark Office on September 23, 2016 at Reel 5883, Frame 0854. Subsequently, Sidran, LLC conveyed a security interest in these two trademarks to Wyoming West Designs II, Inc., which is recorded with the U.S. Patent and Trademark Office at Reel 5884, Frame 0334.
9. Therefore, the current owner of the COWBOY UP (Reg. No. 3,455,083) and COWGIRL UP (Reg. No. 3,455,084) trademark registrations is Sidran, LLC, a Texas limited liability company having an address at 1050 Venture Ct., Suite 100, Carrollton, Texas 75006, as set forth in the last properly recorded assignment on record with the U.S. Patent and Trademark Office concerning these marks, recorded at Reel 5883, Frame 0854.

10. Through this declaration, I am requesting that the U.S. Patent and Trademark Office correct the erroneous assignment of the COWBOY UP (Reg. No. 3,455,083) and COWGIRL UP (Reg. No. 3,455,084) trademark registrations presently recorded at Reel 5854, Frame 0211 to reflect that the owner of these registrations is Sidran, LLC as properly recorded at Reel 5883, Frame 0854.

I declare, under penalty of perjury, that the foregoing is true and correct.

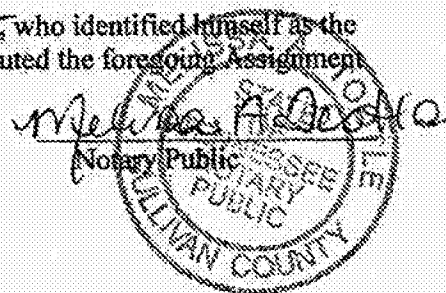
