**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of June 21, 2017 ("Effective Date") by and between Citizens Bank, N.A., a national banking association ("Grantee"), and Willbros Engineers (U.S.), LLC, a Delaware limited liability company ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS by and between Grantor and Grantee dated November 30, 2015 (the "Trademark Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor, including, without limitation, the United States trademark applications and registrations set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith (collectively, the "Trademarks");

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Credit Agreement by and between Grantor and Grantee dated November 30, 2015 (the "Credit Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on November 30, 2015, at Reel 005678, Frame 0125; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests granted under the Trademark Security Agreement, including any and all security interests it has against the Trademarks.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
