TRADEMARK ASSIGNMENT AGREEMENT

This Assignment of Trademark (the "Assignment") is made and entered on 1st June 2017, (the "Effective Date"), by and between
GETPURE, INC., which registered address is 337 Garden Oaks Blvd, Houston, Texas, 77018 United States, Company Incorporation No.: 5155103 (the "Assignor")

and

Misterico limited, which registered address is: Archiepiskopou Makariou III, 73 Methonis Tower, 7th floor, Flat/Office 703, Nicosia, Cyprus 1070, Company Incorporation No HE354720 (the "Assignee") (collectively referred to as the "Parties").

WHEREAS, the Assignor is the owner of the trademarks, as described in Exhibit A attached hereto and incorporated by reference herein (the "Trademarks") and submitted the applications to United States Patent and Trademark Office ("USPTO"), seeking the registration of the Trademarks in the USA;

and

WHEREAS, Assignor wishes to assign his rights in the Trademarks to Assignee.

NOW, THEREFORE, in consideration of the mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, the Parties agree as follows:

1. ASSIGNMENT

For and in valuable consideration, the sufficiency of which is hereby acknowledged, the Assignor does hereby assign and transfer to the Assignee all of Assignor's title and interest in and to the Trademarks, together with:

- 1) the related applications to the USPTO, filed by the Assignor, seeking registration;
- 2) the goodwill of the business relating to the products and services on which the Trademarks are used and for which the applications for registration were filed;
- 3) all income, royalties, and damages hereafter due or payable to Assignor with respect to the marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the marks, and
- 4) all rights to sue for past, present and future infringement or misappropriations of the marks.

2. CONSIDERATION

In consideration for the assignment set forth in Section 1 of the Agreement, the Assignor shall pay the Assignee the sum of 1000 US dollar, payable within 60 days after the Agreement has been signed by the Parties.

3. ASSIGNOR'S REPRESENTATIONS

The Assignor hereby represents and warrants:

- 1) that the Assignor is the exclusive owner of the Trademarks;
- 2) that the Assignor has filed the applications related to the assigned Trademarks to the USPTO;
- 3) that the Assignor has the power to enter into this Assignment;
- 4) that to the best of the Assignor's knowledge, as of the Effective Date the Trademarks do not infringe the rights of any other person or entity;
- 5) that to the best of the Assignor's knowledge, as of the Effective Date the rights transferred in this Assignment are free of any lien, encumbrance or adverse claim, and
- 6) that Assignor has made a good faith effort to use the Trademarks in a way which would permit registration, and that the Trademarks have not been abandoned by the Assignor.

3. ASSIGNEE'S REPRESENTATIONS

The Assignee hereby represents and warrants:

- 1) that the Assignee is a company duly registered and validly existing under the laws of the Republic of Cyprus.
- 2) that the Assignee has full right, power, authority and capacity and all consents and approvals of any other third party and governmental necessary to execute and perform this Agreement, which shall not be against any enforceable and effective laws or contracts.
- 3) once this Agreement has been duly executed by both Parties, the Assignee will record the ownership transfer (assignment) with the USPTO, through the Electronic Trademark Assignment System (ETAS).

4. CONTINUING OBLIGATIONS

The Parties agree to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.

The Assignor agrees to assist the Assignee, upon request, by taking any reasonable action that may be necessary for the perfecting, securing and completing of this Assignment.

The Assignor agrees not to use or make any efforts to use the assigned Trademarks in the future after the assignment is made effective.

5. BINDING EFFECT

The covenants and conditions contained in this Assignment shall be binding on the Assignor and the Assignee and on those who succeed to the interest of the Assignor and the Assignee by law, by approved assignment or by transfer.

6. GOVERNING LAW

This Assignment shall be governed by and construed in accordance with the laws of the State of Texas, United States.

Any dispute, controversy or claim arising out of or relating to this Agreement, or breach, termination or invalidity hereof shall be settled through bona fide negotiations between the Parties.

7. OTHER PROVISIONS

Each Party acknowledges that it has read this Agreement, understands it and agrees to be bound hereby, and represents and warrants that the individual executing this Agreement on its behalf is duly authorized to enter into this Agreement.

If any term, provision or condition of this Agreement shall be held in court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Agreement shall remain in full force and effect.

The terms and conditions of this Agreement can be amended only by a writing signed by both Parties.

8. ENTIRE AGREEMENT

The Parties agree that this Agreement, including the attached Exhibit A, constitutes the complete and exclusive statement of the terms and conditions between them covering the performance of the Agreement. Any representation, warranty or condition, written or otherwise, not expressly contained in this Agreement or in an authorized written amendment thereto shall not be enforceable by either Party. Each of the Parties acknowledges that it has not been induced to enter into this Agreement by any representations not specifically stated herein. This Agreement supercedes all expressly inconsistent representations, whether oral or written, of the Parties pertaining to the subject matter of the Agreement.


