ACCEPTANCE AND ASSIGNMENT OF TRADEMARK RIGHTS

This ACCEPTANCE AND ASSIGNMENT OF TRADEMARK RIGHTS (this "*Agreement*"), effective as of April 30, 2017, is entered into among HO Underwater Acquisition LLC, as the secured party ("*Huish*"), and each of American Underwater Products dba oceanic USA, a California corporation, on behalf of itself and as successor in interest by merger to Ocean Pulse, Inc. ("*AUP*"), Hollis Industries, Inc., a California corporation ("*Hollis*"), and Robert R. Hollis, a resident of the State of California (collectively with AUP and Hollis, the "*Assignors*").

WHEREAS, in connection with certain secured loans described in the Acceptance Agreement referred to below, each of AUP and Hollis pledged and granted to Bridge Bank, National Association, a continuing security interest (the "*Security Interests*") in all or substantially all of their personal property rights and interests (the "*Collateral*"), including their rights and interests in the trademarks listed in **Schedule A** to this Agreement (collectively, the "*Trademarks*");

WHEREAS Huish acquired the Security Interests in the Trademarks and other Collateral pursuant to a Loan Document Purchase and Assignment Agreement with Western Alliance Bank, an Arizona banking corporation, as successor in interest by merger to Bridge Bank, National Association, dated as of March 31, 2017;

WHEREAS Huish and the Assignors, along with other certain affiliated borrowers and guarantors, executed that certain Agreement to Accept Collateral in Partial Satisfaction dated as of March 31, 2017, as amended and restated pursuant to that certain Amended and Restated Agreement to Accept Collateral in Partial Satisfaction and Additional Asset Purchase & Sale Agreement dated as of April 28, 2017 (each individually and both together, the "*Acceptance Agreement*");

WHEREAS, in furtherance of the Acceptance Agreement, on April 7, 2017 Huish caused a "Notification of Proposal to Accept Collateral From American Underwater Products and Hollis Industries, Inc. in Partial Satisfaction of Secured Indebtedness" to be delivered by certified mail to the Assignors and all other parties entitled to notice of Huish's proposed acceptance of the Trademarks and other Collateral subject to the Security Interests (the "*Acceptance*") pursuant to Section 9-621 of the Uniform Commercial Code, as presently in effect in the State of California;

WHEREAS in the Acceptance Agreement AUP and Hollis agreed to transfer and assign to Huish, and Huish agreed to accept, all of AUP's and Hollis's right, title and interest in and to the Collateral granted by them (except for certain items of equipment that were subject to senior security interests), including all Trademarks in which they have any rights, in partial satisfaction of the secured indebtedness; and

WHEREAS in the Acceptance Agreement the Assignors agreed to cooperate with Huish, from and after the date of the Acceptance, in executing appropriate instruments of transfer evidencing the Acceptance and related transactions, including without limitation signing assignments of patents and trademarks for filing with the U.S. Patent and Trademark Office and its foreign counterparts,

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignors agree as follows:

1. Assignment. Each of the Assignors hereby sells, assigns and transfers to Huish its entire right, title, and interest in and to the Trademarks, all related common law rights and the goodwill pertaining thereto, together with all claims, demands and causes of action for the past infringement of any or all of the Trademarks or for unfair competition in business in connection therewith, and all rights to sue at law

or in equity for any infringements, misappropriations or other violations of any of the foregoing, including the right to receive all proceeds and damages therefrom, to be held and enjoyed by Huish, its successors, assigns or other legal representatives as fully and entirely as the same would or could have been held and enjoyed by each of the Assignors had this assignment not been made.

2. Purpose. The parties agree that Huish shall cause this Agreement to be recorded with the U.S. Patent and Trademark Office and any other governmental entity.

3. Acknowledgment. Assignors hereby further acknowledge and affirm the rights and remedies of Huish with respect to the Security Interests as provided in the Acceptance Agreement.

4. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be duly executed and delivered by their respective officers as of the date first set forth above.
