**NUNC PRO TUNC AMENDMENT TO TRADEMARK ASSIGNMENT**

B. **WHEREAS**, in connection with the APA, Assignor and Assignee entered into that certain Trademark Assignment dated April 18, 2017 (the "Trademark Assignment").

C. **WHEREAS**, Schedule A to the Trademark Assignment failed to include the OASIS trademark application that is being transferred to Assignee in connection therewith.

D. **WHEREAS**, Assignor and Assignee now wish to revise Schedule A to the Trademark Assignment as set forth herein to include the subject trademark application and to reflect the intent of the Parties on the date of execution of the Trademark Assignment.

**NOW THEREFORE**, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby amend the Trademark Assignment as follows:

1. Schedule A of the Trademark Assignment is hereby deleted in its entirety and replaced with the following new Schedule A, attached hereto as Exhibit A.

2. In all other respects, the remaining terms, covenants, conditions and provisions of the Trademark Assignment shall continue in full force and effect to the extent provided in the Trademark Assignment.
