FIRST SUPPLEMENT TO GRANT OF SECURITY INTEREST
IN UNITED STATES AND CANADIAN TRADEMARKS

This First Supplement to Grant of Security Interest in United States and Canadian Trademarks (this "Grant") is made as of the 28th day of June, 2017, by **RH US, LLC**, a Delaware limited liability company (the "Grantor") in favor of **BANK OF AMERICA, N.A.**, as Agent (the "Grantee").

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated January 30, 2015 and recorded with the USPTO on March 18, 2015 at Reel 005481, Frame 0054 and with CIPO on April 20, 2014 as File No. 1592876 (the "Original Grant") in favor of the Grantee, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Marks (as defined therein); and

WHEREAS, the Grantor has developed additional Marks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Marks in favor of the Grantee.


NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Original Grant.
2. Supplement to Schedule A. Schedule A to the Original Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto. For the purposes of clarity, from and after the date hereof, Schedule A shall be deemed to include (i) the Marks referenced on Schedule A as such Schedule A exists immediately prior to the date hereof, and (ii) the Marks referenced on Schedule A-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Original Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Grant and the Original Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.
