PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

The validity, interpretation and enforcement of this Partial Release of Security Interest in Trademarks and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.


