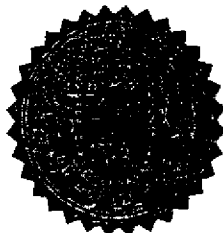

Autobytel Bedrock Corp., a corporation organized and existing under and by virtue of the Delaware General Corporation Law, does hereby certify that:

1. The name and state of incorporation of each of the constituent corporations of the merger are as follows:

2. An Acquisition Agreement dated as of April 15, 2004, among Autobytel Inc., a Delaware corporation, Autobytel Bedrock Corp., Stoneage Corporation ("Disappearing Corporation"), and certain current and former shareholders of Disappearing Corporation (the "Merger Agreement"), pursuant to which Disappearing Corporation will be merged with and into Autobytel Bedrock Corp. with Autobytel Bedrock Corp. being the surviving corporation (the "Surviving Corporation") of the merger (the "Merger"), has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 252 of the Delaware General Corporation Law.

3. The authorized capital stock of Disappearing Corporation is 10,000,000 shares, consisting of 9,900,000 shares of Common Stock, \$0.01 par value per share, and 100,000 shares of Preferred Stock.

4. As a result of the Merger, from and after the effective time of the Merger, the Certificate of Incorporation of Autobyte Bedrock Corp. in effect immediately prior to the Merger shall be the Certificate of Incorporation of the Surviving Corporation, except that Article FIRST thereof shall be amended to read as follows: "The name of this corporation is Car.com, Inc. (the "Corporation")."


5. An executed copy of the Merger Agreement is on file at the office of the Surviving Corporation, at 18872 MacArthur Blvd., Irvine, California 92612-1400.

6. A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either constituent corporation.
