**FIRST LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of June 30, 2017, by SUNTRUST BANK, a Georgia corporation (the “Collateral Agent”) in favor of GLOBAL HEALTHCARE EXCHANGE, LLC, a Delaware limited liability company and VENDORMATE INCORPORATED, a Georgia corporation, both of which have an address at 1315 West Century Drive, Suite 100, Louisville, CO 80027 (collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated August 13, 2015 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on August 14, 2015 at the United States Patent and Trademark Office at:

1. Reel 5601, Frame 0391; and
2. Reel 5601, Frame 0350.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantors granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in and to their Collateral, including the Trademarks listed in Schedule I, and all the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Collateral of the Grantors, and all of the goodwill of the business symbolized thereby, and assigns, transfers and conveys to Grantors any interest in such Collateral, including the Security Interest.


