TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 27, 2017 (this "Release"), is made by **CREDIT SUISSE AG**, as Administrative Agent for the Secured Parties (in such capacity and together with its successors and assigns thereto in such capacity, the "Agent"), in favor of **PEM MANAGEMENT, INC.**, a Delaware corporation (the "Grantor").

WHEREAS, the Grantor, the other grantors party thereto and the Agent entered into that certain Security Agreement, dated as of August 29, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which Grantor executed and delivered to the Agent that certain Trademark Security Agreement, dated as of August 29, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 29, 2014, at reel/frame number 005354/0631;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreement, the Grantor assigned, transferred and granted to the Agent, for the benefit of the Secured Parties, a security interest (the "Security Interest") in the Trademark Collateral (as defined below); and

WHEREAS, the Agent desires to terminate and release the entirety of the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

SECTION 1. Defined Terms.

The term "Trademark Collateral" shall have the meaning given thereto in the Trademark Security Agreement, including, without limitation, all of the Grantor's right, title and interest in, to and under the registrations and applications for registration listed in Schedule A attached hereto. Capitalized terms used but not defined herein shall have the respective meanings given thereto in the Security Agreement and, if not defined therein, in the Credit Agreement.


SECTION 2. Release of Security Interest.

The Agent hereby terminates, releases and discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to the Grantor any right, title or interest of the Agent in, to or under the Trademark Collateral, without representation, warranty or recourse of any kind.


