**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 30, 2017 (this “Termination”), is made by GOLDMAN SACHS BDC, INC., a Delaware corporation, as collateral agent (in such capacity, including any successor thereto, the “Collateral Agent”) for the Secured Parties under that certain Trademark Security Agreement, dated as of August 3, 2015 (as amended, supplemented or modified and in effect from time to time, the “Trademark Security Agreement”) by and among INTEGRATED PRACTICE SOLUTIONS, INC. dba CHIROTOUCH, a Delaware corporation (“IPS”), INTEGRATED PRACTICE SOLUTIONS, INC. (as successor by merger to FUTURE HEALTH ACQUISITION, INC.), a Delaware corporation (“Future Health”, and together with IPS, collectively, the “Grantors” and each a “Grantor”) and the Collateral Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on August 3, 2015 at reel 5590, frame 0559, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of Grantors’ right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule I;

WHEREAS, the Secured Obligations secured by the Trademark Collateral have been repaid; and


WHEREAS, the Grantor’s have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its lien and security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Collateral Agent in the Released Collateral.
