RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of June 29, 2017 (“Effective Date”) by BANK OF AMERICA, N.A. (the “Administrative Agent”) in favor of Phibro Animal Health Corporation, Prince Agri Products, Inc. and Omnigen Research, LLC (each, a “Pledgor” and collectively, the “Pledgors”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, the Pledgors are a party to that certain Security Agreement dated April 16, 2014 (as amended, restated or otherwise modified from time to time, the “Security Agreement”) in favor of the Administrative Agent;

WHEREAS, the Pledgors and Administrative Agent entered into that certain Trademark Security Agreement dated April 16, 2014 (the “Trademark Security Agreement”), to record the continuing security interest in all right, title and interest of the Pledgor in, to and under (a) all of its Trademarks, including, without limitation, those listed on Schedule 1 hereto, (b) all renewals of the foregoing, (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement or other violation thereof (collectively, the “Trademark Collateral”), and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 17, 2014, at Reel 5263, Frame 0517; and

WHEREAS, each Pledgor requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby, without representation, warranty or recourse of any kind, on behalf of itself and the Secured Parties, terminates the Trademark Security Agreement and releases and re-assigns to the Pledgors, as applicable, any and all liens, security interests, right, title and interest it may have in, to and under the Trademark Collateral, together with the goodwill of the business symbolized thereby.


Administrative Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer, employee or agent note and record the release hereby given and any other filings necessary to evidence the release and termination of the Administrative Agent’s rights under each of the Security Agreement and Trademark Security Agreement, with respect to the Trademark Collateral.

This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
