**SECOND LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks ("Trademark Release") is made as of June 30, 2017, by SUNTRUST BANK, a Georgia corporation (the "Collateral Agent") in favor of MRI SOFTWARE LLC and WORKSPEED HOLDINGS, LLC (both of which are Delaware limited liability companies with an address at 28925 Fountain Parkway, Solon, Ohio 44139) (collectively, the "Pledgors").

WITNESSETH:

WHEREAS, the Pledgors entered into a certain Second Lien Trademark Security Agreement dated June 23, 2015 (the "Trademark Security Agreement") with the Collateral Agent, notice of which was recorded on June 24, 2015 at the United States Patent and Trademark Office at Reel 5560, Frame 0189 and Reel 5560, Frame 0222.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Pledgors granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to their Trademark Collateral, including the Trademarks listed in Schedule I, and all the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgors, and all of the goodwill of the business symbolized thereby, and assigns, transfers and conveys to Pledgors any interest in such Trademark Collateral, including the Security Interest.
