Assignor agrees to execute and deliver at the request of the Assignee, any papers, instruments and assignments reasonable to vest in Assignee all of Assignor's right, title and interest in and to the Marks as well as the applications and registrations and any renewals or extensions of any applications and registrations for such Marks and/or to provide evidence to support such assignment in the event such evidence is reasonably necessary and to the extent such evidence is in the possession or control of Assignor.

This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective representatives, successors and assigns. This Assignment, together with the Asset Purchase Agreement, sets forth the entire understanding of the parties, and supersedes and preempts all prior oral or written understandings, discussions and agreements with respect to the subject matter hereof. In the event of any conflict between this Assignment and the Asset Purchase Agreement, the Asset Purchase Agreement shall control.


