The undersigned hereby certify that:

2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:


“The name of this corporation is Stone Valley Mortgage, Inc.”

3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.



The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%). The percentage vote voting in favor of the Amended Articles of Incorporation was one hundred (100%).
