RELEASE OF SECURITY INTEREST IN TRADEMARKS AND TRADEMARK LICENSES

This RELEASE OF SECURITY INTEREST IN TRADEMARKS AND TRADEMARK LICENSES is dated as of June 26, 2017, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as successor by merger of Wachovia Bank, National Association, as the Lender, as defined in the Collateral Agreement referenced below (in such capacity, together with its successors and assigns in such capacity, the "Lender").

WHEREAS, Lender and PETTY HOLDINGS LLC, a Delaware limited liability company ("Grantor"), and the other borrowers and guarantors party thereto (each an "Obligor" and together with the Grantor, the "Obligors") entered into (i) that certain Collateral Agreement dated as of July 1, 2008 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the "Collateral Agreement"), and (ii) that certain Trademark Security Agreement dated as of July 1, 2008 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the "Trademark Agreement"), and together with the Collateral Agreement, the "Security Documents";

WHEREAS, the Security Documents granted Lender a security interest in, among other things, certain Trademarks, Trademark registrations and Trademark applications ("Trademarks") and certain Trademark licenses, including, without limitation, the Trademarks and Trademark licenses listed on Schedule I attached hereto as security for certain obligations of Obligors to Lender (the "Obligations");

WHEREAS, Lender recorded the Trademark Agreement on July 3, 2008 at Reel 003809, Frame 0427 with the United States Patent and Trademark Office; and

WHEREAS, Grantor has requested that Lender release its security interests in the Trademarks and Trademark licenses listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby fully discharges, releases and terminates its security interests in and liens on the Trademarks and Trademark licenses listed on Schedule I hereto and any right, title or interest of the Lender in the foregoing under the Security Documents shall hereby cease and become void.
