RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of June 30, 2017 ("Effective Date") by and between SILICON VALLEY BANK, a California corporation, ("Grantee"), and RISKONNECT, INC., a Delaware corporation, ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Grantee dated February 10, 2015 (the "Intellectual Property Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the intellectual property, and registrations of and applications to register the foregoing, including, without limitation, the United States patent registrations and applications set forth on Schedule A attached hereto, and the United States trademark registrations set forth on Schedule B attached hereto, in each case, together with the goodwill associated therewith (collectively, the "Intellectual Property");

WHEREAS, Grantor and Grantee entered into the Intellectual Property Security Agreement pursuant to the terms and conditions of that certain Loan Agreement by and between Grantor and Grantee dated February 10, 2015 (the "Loan Agreement");

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Intellectual property Office ("PTO") on February 18, 2015, at Reel 5461, Frame 0557 with respect to trademarks, and also at Reel 034977, Frame 0802 with respect to patents;

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels and releases any and all security interests it has in or against the Intellectual Property.



Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
