RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made and effective as of June 26, 2017 (“Effective Date”) and granted to HOMEWORKS, INC. (n/k/a ARHAUS, LLC), an Ohio limited liability company (the “Grantor”) by KEYBANK NATIONAL ASSOCIATION (“KeyBank”), a national banking association.

WHEREAS, pursuant to that certain Credit and Security Agreement, dated as of April 29, 2005 (as amended and restated, supplemented or otherwise modified from time to time, in accordance with its terms, the “Credit and Security Agreement”), by and between the Grantor and KeyBank, the Grantor executed that certain Intellectual Property Collateral Assignment Agreement, dated as of April 29, 2005 (the “IP Assignment”), in favor of KeyBank;

WHEREAS, pursuant to the terms and conditions of the IP Assignment, as security for the prompt and complete payment and performance when due of all of its Secured Obligations, the Grantor pledged and granted to KeyBank a security interest in all of the Grantor’s Intellectual Property, including, without limitation, those items set forth on Schedule 1 attached hereto (collectively, the “IP Collateral”);

WHEREAS, the IP Assignment was recorded with the United States Patent and Trademark Office at Reel 3089, Frame 0293 on April 29, 2005; and

WHEREAS, the Grantor has requested that KeyBank enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest KeyBank may have in the IP Collateral pursuant to the IP Assignment.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, KeyBank hereby states as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, capitalized terms used in this Release, including its preamble and recitals, but not defined herein shall have the meaning provided or provided by reference in the Credit and Security Agreement or IP Assignment, as applicable.

2. Release of Security Interest in IP Collateral.

2.1 Without recourse and without representation and warranty of any kind, KeyBank hereby: (i) terminates, cancels and releases any and all security interests it has against the IP Collateral, and (ii) consents to the termination of the IP Assignment with respect to such IP Collateral.

2.2 KeyBank hereby authorizes Grantor or any of its authorized representatives to file this Release with the United States Patent and Trademark Office (the “USPTO”) or any other applicable governmental office. KeyBank hereby further authorizes and requests that the USPTO record this Release.

3. Miscellaneous.

3.1 Governing Law. This Release and the rights and obligations of the parties hereunder shall be construed in accordance with and be governed by the law of the State of Ohio, without regard to any choice or conflict of law principle that would require or permit the laws of any other jurisdiction to apply.


3.2 Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
