GRANT OF SECURITY INTEREST IN
TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, RH YOUNTVILLE, INC., a Delaware corporation (the "Grantor"), with principal offices at 15 Koch Road, Suite J, Corte Madera, California 94925, hereby grants to WILMINGTON TRUST, NATIONAL ASSOCIATION, as Agent, with offices at Rodney Square North, 1100 North Market Street, Wilmington, Delaware 19890 (the "Grantee"), a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under the trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications (the foregoing, collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement, as hereinafter defined) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to, concurrently with, or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Grant") is made to secure the satisfactory performance and payment of all the Grantor's Secured Obligations, as such term is defined in the Security Agreement by, among others, the Grantor, the other Grantors from time to time party thereto and the Grantee, dated as of July 7, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").


