RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of July 7, 2017 (the "Effective Date"), by FIRST MIDWEST BANK (the "Lender"), in favor of the Grantor (as defined below). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan and Security Agreement (as defined below) and the Intellectual Property Security Agreement (as defined below), as applicable.

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of May 4, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among CHUDY GROUP, LLC, a Delaware limited liability company, as a Borrower and Lead Borrower for the other Borrowers (the "Grantor"), the other Borrowers and the Lender, the Grantor granted to the Lender a lien on and security interest in the Intellectual Property Collateral, including those trademarks and patents set forth on the attached Exhibits A and B;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Lender that certain Intellectual Property Security Agreement, dated as of May 4, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement") for recordation with the United States Patent and Trademark Office (the "USPTO");

WHEREAS, the IP Security Agreement was recorded with the USPTO on June 8, 2012 with the trademark assignment division at Reel 4798, Frame 0189;

WHEREAS the IP Security Agreement was recorded with the USPTO on May 16, 2012 with the patent assignment division at Reel 028216, Frame 0164; and

WHEREAS, the Lender now desires to release its lien on and security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender, hereby agrees as follows:

The Lender hereby terminates the IP Security Agreement, and hereby terminates and releases the security interest in the Intellectual Property Collateral arising under the Security Agreement and the IP Security Agreement.

If and to the extent the Lender has acquired any right, title or interest in, to or under any of the Intellectual Property Collateral, it hereby irrevocably reassigns and retransfers all such right, title and interest to the Grantor.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.


