**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of July 7, 2017 is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Collateral Agent, ("Agent"), under that certain Trademark Security Agreement, made as of April 3, 2013, by ATKINS NUTRITIONALS, INC., a New York corporation ("Borrower"), in favor of the Agent (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement").




