**TERMINATION AND RELEASE OF  
SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Second Lien Security Interest in Trademarks (“Trademark Release”) is made as of June 26, 2017, by MC Admin Co LLC (the “Collateral Agent”) in favor of Transtelco Inc., a Texas corporation with offices at 500 W. Overland Ave., Suite 310, El Paso, Texas 79901 (the “Grantor”).

WITNESSETH:

WHEREAS, Grantor entered into a certain Second Lien US Security Agreement dated November 19, 2013 (“Security Agreement”) with the Collateral Agent;

WHEREAS, Grantor entered into a certain Grant of Security Interest in United States Trademarks dated November 19, 2013 (the “Second Lien Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on Nov. 22, 2013, at the United States Patent and Trademark Office at Reel 5159, Frame 0240;

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Security Agreement and Second Lien Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to the Trademark Collateral; and

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound:

1. Defined Terms. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Second Lien Trademark Security Agreement.
2. Release. The Collateral Agent, for itself and on behalf of the Secured Creditors, acknowledges the satisfaction and termination of the Security Interest granted under the Security Agreement and Second Lien Trademark Security Agreement and hereby releases, terminates, and discharges any and all of its interest in the intellectual property of the Grantor, including the Trademark Collateral and all of the goodwill associated therewith. The Collateral Agent hereby assigns, transfers, and conveys to Grantor all of its right, title, and interest in and to the Trademark Collateral. Collateral Agent acknowledges and agrees that, as a result of this Trademark Release, it has no further rights to or interest in the Trademark Collateral.
3. Recordation. The Collateral Agent authorizes and requests the governing body of the United States Patent and Trademark Office to record this Trademark Release.
