RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on June 29, 2017, by REGIONS BANK, as administrative agent (the "Bank"), to the Grantor listed on Schedule A (the "Grantor").

FURTHERMORE, the Bank hereby authorizes the Grantor and its authorized representatives to record this Release with the United States Patent and Trademark Office.


