RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (the “Release”), dated as of June 19, 2017 is made by **WEBSTER BANK, NATIONAL ASSOCIATION**, a national banking association, as agent (in such capacity, the “Agent”) for itself and for the Secured Parties.

WHEREAS, **DATABASE SPECIALISTS, INC.**, a California corporation (“Debtor”), and Agent are parties to that certain Trademark Security Agreement, dated as of September 30, 2016 (the “Agreement”), which was recorded with the United States Patent and Trademark Office on October 13, 2016 in its records at Reel 5898, Frame 0796. Capitalized terms used but not defined herein will have the meaning as assigned to them in the Agreement or the LSA;

WHEREAS, the Agreement granted to the Agent a security interest in all of each Debtor’s right, title and interest in and to all of its Collateral, including, without limitation: (a) all of each Debtor’s right, title and interest in and to all of its now or in the future owned or existing trademarks (the “Trademarks”) listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all reissues, extensions and renewals of the Trademarks; (c) all income and royalties with respect to any license for the Trademarks; (d) all rights to sue for past, present or future infringement or uncontested use of the Trademarks; (e) all rights of Debtor as licensor or licensee under, and with respect to the Trademarks; and (f) together in each case with the goodwill of each Debtor’s business connected with the use of, and symbolized by, the foregoing; and


WHEREAS, Agent desires to release its rights and security interests in the Collateral, including the Trademarks, solely as granted under the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademarks; and (ii) any and all other rights it may have under the Agreement.
