RELEASE OF TRADEMARK COLLATERAL RIDER

THIS RELEASE OF TRADEMARK COLLATERAL RIDER (this "Release"), dated as of July 11, 2017, is made by **ALLIANCE BUSINESS LENDING, LLC**, a Kentucky limited liability company ("Secured Party"), and is as follows:

WHEREAS, **AFTERMATH SERVICES LLC**, a Delaware limited liability company ("Debtor"), and Secured Party are parties to that certain Trademark Collateral Rider dated as of February 5, 2016 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on February 18, 2016, in its records at Reel 5735, Frame 0319. Capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Secured Party a security interest in all of the Debtor's right, title and interest in, to and under the Trademark Collateral, including, without limitation: (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Schedule 2 of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under, or with respect to, any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks; (d) all rights to sue for past, present and future infringements of any and all Trademarks; (e) all rights corresponding to each of the Trademarks throughout the United States; (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications, including the Trademark Licenses; (g) the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and (h) all books, records, cash and non-cash proceeds of any and all of the foregoing;

WHEREAS, Secured Party represents that it has not assigned the Agreement to any Person; and


WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (a) its security interest in and Lien on, and other rights in, to and under the Trademark Collateral and (b) any and all other rights it may have under the Agreement.
