**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is effective as of June 29, 2017 (“Effective Date”) by WELLS FARGO BANK, NATIONAL ASSOCIATION, as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”) in favor of BEVERAGES & MORE, INC. (the “Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, the Grantor and the Collateral Agent entered into (i) that certain Indenture, dated as of February 27, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the “Indenture”), and (ii) that certain Security Agreement, dated as of February 27, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), which required the parties to enter into the Trademark Security Agreement (defined below);

**WHEREAS**, the Grantor and the Collateral Agent entered into that certain Trademark Security Agreement, dated February 27, 2007 (the “Trademark Security Agreement”), under which the Grantor granted a security interest in favor of, and collaterally assigned to the Collateral Agent, for the benefit of the Secured Parties, in and to the Marks (as defined in the Trademark Security Agreement), including, without limitation, those listed on Exhibit A annexed hereto and made a part hereof, together with any goodwill connected therewith and symbolized thereby; and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 2, 2007, at Reel 3491, Frame 0932; and

**WHEREAS**, the Grantor has previously, as of September 27, 2010, satisfied the terms of the Security Agreement and the Trademark Security Agreement and requests that the Collateral Agent execute and deliver this Release to evidence the release of the security interest granted and recorded against the Marks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement, (ii) releases any and all liens, security interests, right, title and interest the Collateral Agent or any Secured Party may have in, to or under the Marks, and (iii) re-assigns to the Grantor, any right, title or interest the Collateral Agent or any Secured Party may have in, to or under the Marks, together with the goodwill of the business symbolized thereby.

Any questions, claims, disputes, remedies or actions arising from or relating to this Release, and any relief or remedies sought by any parties, shall be governed exclusively by the laws of the State of New York without regard to the rules of conflict of laws applied therein or any other jurisdiction.
