TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of July 13, 2017 by **SILICON VALLEY BANK**, as Assignee (the "*Assignee*"), in favor of **STAT HEALTH, LLC**, a Delaware limited liability company ("*Stat*"), **HY HOLDINGS, INC.**, a Delaware limited liability company ("*HY*"), and **TELADOC, INC.**, a Delaware corporation ("*Teladoc*", and together with Stat and HY, each individually, a "*Grantor*", and collectively, the "*Grantors*").

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement, dated as of July 11, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on July 12, 2016, at Reel 5833, Frame 0001;

WHEREAS, Grantors have requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantors in, to and under all of the trademarks and trademark applications described in the Grant (the "*Trademarks*") as herein provided; and

WHEREAS, Grantors have requested that the Assignee provide a document suitable for recording in the USPTO to evidence the release of the Assignee's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges fully, without representation, warranty or recourse of any kind, all liens and continuing security interests in each Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
