The Commissioner of Patents and Trademarks is requested to record this Assignment.

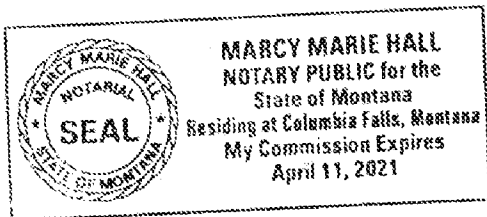
