GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

The rights and remedies of Grantee with respect to the security interest granted herein are as set forth in the Guaranty and Collateral Agreement. In the event that any provisions of this Grant are deemed to conflict with the Guaranty and Collateral Agreement, the provisions of the Guaranty and Collateral Agreement shall govern.
