RELEASE OF SECURITY INTEREST

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Lender, on behalf of itself, its successors, legal representatives and assigns, hereby releases, terminates and discharges its security interest in and to the Released Trademarks to Assignor, according to its interests therein, without representation or warranty of any kind, express or implied, free and clear of any claims by Lender, all of Lender's right, title and interest in and to the Released Trademarks, the goodwill associated therewith, and all causes of action for past infringement, if any.


