NOW THIS DEED WITNESSETH as follows:


- 1) In consideration of the sum of RMB...0,00.... paid by the Assignee to the Assignor (receipt of which is hereby acknowledged) the Assignor hereby as registered owner assigns unto the Assignee ALL the property, right, title and interest in the Trade Mark TOGETHER with the goodwill of the business relating to the goods in respect of which the Trade Mark is registered.
- 2) The Assignor covenants that he will execute all documents, papers, forms and authorizations and depose to or swear all declarations or oaths which may be necessary for securing, completing or absolutely vesting full right, title and interest

to the Trade Mark, or of conferring on him all rights of action to infringement and any passing of by third parties at the date hereof.

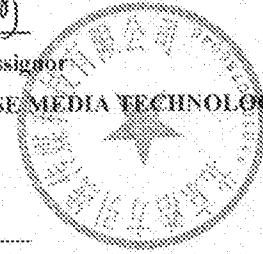
- 3) The Assignor is the proprietor of the Trade Mark and has full power to enter into this agreement.
- 4) The Assignor has not by any act or omission caused and permitted anything to be done which might jeopardize the validity of the Trade Mark registration or the ability of the Assignee to register this agreement.
- 5) The Trade Mark does not infringe any mark belonging to any other party.
- 6) The Assignor will keep the Assignee indemnified against all actions, claims, proceedings, costs and damages and all legal proceedings arising out of any breach of the above warranties.
- 7) The Assignor has not withheld any information from the Assignee about the validity or registrability of the Trade Mark.



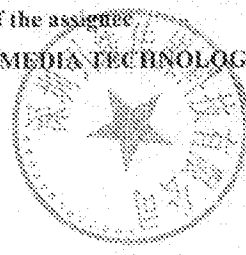
