This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of June 29, 2015, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as agent (the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Third Amended and Restated Credit Agreement dated as of September 26, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "**Credit Agreement**"), among Parfums de Coeur, Ltd., a Connecticut corporation ("**PDC**"), Parfums Acquisition Company, Inc., a Delaware corporation (together with PDC, the "**Borrowers**"), PDC, as Borrower Representative, Parfums Holding Company, Inc., a Delaware corporation, the other Credit Parties, the Lenders from time to time party thereto and the Agent, and together with all general security agreements, trademark security agreements, patent security agreements and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the Lenders made loans and other financial accommodations to the Borrowers;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), PDC and Ilex Consumer Products Group, LLC, a Delaware limited liability company (together with PDC, the "**Grantors**") granted security interests in the certain intellectual property owned by Grantors, including those listed on Annex I attached hereto (the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office on the dates and on the reels and frames set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral to Grantors.




