ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS

THIS ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS (the “Assignment”) is made and entered into as of June 21, 2017 by MACQUARIE US TRADING LLC, a Delaware limited liability company, as the original administrative agent (in such capacity, “Assignor”), in favor of CORTLAND CAPITAL MARKET SERVICES LLC, a Delaware limited liability company with an address at 225 W. Washington St., 21st Floor, Chicago, Illinois 60606, as the successor collateral agent (in such capacity, “Assignee”).

W I T N E S S E T H

WHEREAS, Assignor is party to that certain Credit Agreement, dated as of July 9, 2013 (as amended, restated, amended and restated, waived or otherwise modified from time to time, the “Credit Agreement”), among New Publishing Holdings, Inc. (“Holdings”), F+W Media, Inc., (the “Borrower”), each Lender party thereto from time to time, and each Subsidiary Guarantor listed on the signature pages here (collectively the “Grantors”), the other grantors party thereto, and Assignor;

WHEREAS, in connection with the Credit Agreement, the Borrower executed and delivered a Guarantee and Collateral Agreement, dated as of July 9, 2013, in favor of the Assignor (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Guarantee and Collateral Agreement”);

WHEREAS, pursuant to (i) the Credit Agreement, (ii) the Guarantee and Collateral Agreement and (iii) all of the trademark security agreements made by the Grantors in favor of Assignor, including those which were recorded at the United States patent and Trademark Office at Reel/Frame 5074/0654, Reel/Frame 5248/0259, Reel/Frame 5248/0246, Reel/Frame 5248/0643, Reel/Frame 5359/0948, Reel/Frame 5247/0278, Reel/Frame 5249/0595 and Reel/Frame 5250/0861 (the “Trademark Security Agreements”), the Grantors have granted to Assignor a continuing security interest in, and lien on, all of its right, title and interest in, to and under the Trademarks (as such term is used in the Trademark Security Agreements) as set forth under the Guarantee and Collateral Agreement and Trademark Security Agreements, including those trademark registrations and applications set forth on Schedule A (the “Trademark Collateral”); and

WHEREAS, pursuant to that certain Agency Assignment Agreement, dated as of May 24, 2017, among the Assignor, Assignee, Holdings, Borrower and each Subsidiary Guarantor, Assignor has resigned as administrative agent under the Credit Agreement and other Loan Documents, and Assignee has assumed and succeeded to all of the rights, powers, duties and obligations of Assignor as administrative agent thereunder; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to evidence the assignment by Assignor to Assignee of all of Assignor’s right, title and interest in, to and under the Credit Agreement, Guarantee and Collateral Agreement, and the Trademark Security Agreements, including, without limitation, Assignor’s security interest in, and lien on,

the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby covenant and agree as follows:

1. Terms. Capitalized terms used in this Assignment and not otherwise defined herein shall have the meanings specified in the Credit Agreement.
2. Assignment. Assignor hereby transfers, assigns, grants and conveys to Assignee for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the Credit Agreement, the Guarantee and Collateral Agreement, and the Trademark Security Agreements, including, without limitation, its security interest in, and lien on, the Trademark Collateral, and Assignee hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and liens.
3. Acknowledgment of Grantors. The security interest assigned to Assignee as the new collateral agent for the Secured Parties pursuant to this Assignment, has been granted in conjunction with the security interest granted pursuant to the Credit Agreement, Guarantee and Collateral Agreement and Trademark Security Agreements, and the Grantors hereby (i) confirm their grant to Assignee of a security interest in, and lien on, the Trademark Collateral to secure the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations (as such term is defined in the Guarantee and Collateral Agreement) and (ii) acknowledge and affirm that the rights and remedies of Assignee with respect to its security interest in, and lien on, the Trademark Collateral are more fully set forth in the Credit Agreement, the Guaranty and Collateral Agreement, and the Trademark Security Agreements, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.
5. Counterparts. This Assignment may be executed in counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile transmission or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.


