RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of July 19, 2017 (the "Effective Date"), is made by Citibank, N.A., in its capacity as Administrative Agent (the "Agent"), in favor of the grantor party identified on the signature page hereto (the "Grantor").

WHEREAS, pursuant to that certain Security Agreement, dated as of November 12, 2015, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantor granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor and certain other parties executed and delivered a Copyright Security Agreement, dated as of November 12, 2015 (the "Copyright Security Agreement"), for recordal with the United States Copyright Office;

WHEREAS, the Copyright Security Agreement was recorded with the United States Copyright Office on November 19, 2015 at Volume/Document 9926/504;

WHEREAS, pursuant to the Security Agreement, the Grantor and certain other parties executed and delivered a Trademark Security Agreement, dated as of November 12, 2015 (the "Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 19, 2015 at Reel/Frame 5672/0415;

WHEREAS, pursuant to the Security Agreement, the Grantor and certain other parties executed and delivered a Patent Security Agreement, dated as of November 12, 2015 (the "Patent Security Agreement"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on November 19, 2015 at Reel/Frame 037146/0724;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement, Copyright Security Agreement, Trademark Security Agreement or the Patent Security Agreement.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to (collectively, the "Released Collateral"):

- (i) the Patent Collateral owned by the Grantor set forth on Schedule A attached hereto,
- (ii) the Copyright Collateral owned by the Grantor set forth on Schedule B attached hereto,
and

(iii) the Trademark Collateral owned by the Grantor set forth on Schedule C attached hereto, in each case, arising under the Security Agreement and the Copyright Security Agreement, the Trademark Security Agreement and the Patent Security Agreement, as applicable. If and to the extent that the Agent has acquired any right, title or interest in and to the Released Collateral under any of the Patent Security Agreement, the Copyright Security Agreement or the Trademark Security Agreement, as applicable, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Limitation. This Release is applicable only and solely with respect to the Released Collateral and not to any other collateral arising under the Security Agreement or the Copyright Security Agreement, the Trademark Security Agreement or the Patent Security Agreement (the "Retained Collateral"). The Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Agent under the Security Agreement, the Copyright Security Agreement, the Trademark Security Agreement and the Patent Security Agreement with respect to all such Retained Collateral, and the Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

4. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
