TASI Holdings, Inc., a corporation organized and existing under the laws of the State of Delaware (the "*Company*"), DOES HEREBY CERTIFY:

FIRST: That the Company was incorporated on the 4th day of September, 2003, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Company owns all of the outstanding shares of the stock of Total Automated Solutions, Inc. ("*TASI*"), a corporation incorporated on the 20th day of December, 1999, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That the Company, by the following resolutions of its Board of Directors, duly adopted by the unanimous written consent of its members, filed with the minutes of the Board on the 19 day of December, 2005, determined to and did merge into itself TASI:

RESOLVED, that the Company merge, and it hereby does merge, into itself TASI and assumes all of its obligations;

FURTHER RESOLVED, that the merger shall be effective upon the date of filing with the Secretary of State of Delaware; and

FURTHER RESOLVED, that the officers of the Company be, and each of them hereby is, directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge TASI and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State of Delaware and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be necessary or proper to effect the merger.

FOURTH: Anything herein or elsewhere to the contrary notwithstanding, this merger may be amended or terminated and abandoned by the Board of Directors of the Company at any time prior to the time that this merger filed with the Secretary of State becomes effective.
