Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

ARTICLE TWO

The amendment changes the Articles of Incorporation to change the article that names the corporation. The following amendment replaces Article I of the current Articles of Incorporation in its entirety and the full text of Article I as altered is as follows:

The name of the corporation is Ameriforge Group Inc."


ARTICLE THREE
