RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (“Release”) dated July 21, 2017 is made by Antares Capital LP, a Delaware limited partnership (as successor to General Electric Capital Corporation), having a business address at 500 West Monroe Street, Chicago, IL 60661, (hereinafter “Secured Party”), and Sports Information Group, LLC (f/k/a Daily Racing Form LLC), Daily Racing Form Services LLC, and Sports Enthusiast Media LLC (collectively, the “Debtors”).

W I T N E S S E T H:

WHEREAS, Debtors and Secured Party are parties to a certain (i) Trademark Security Agreement, executed October 19, 2007 (as amended, restated, amended and restated, modified or supplemented prior to the date hereof, “2007 Trademark Security Agreement”), pursuant to which Debtors granted to Secured Party a security interest in its intellectual property, including the trademarks listed on Schedule A hereto, which was recorded with the United States Patent and Trademark Office (the “USPTO”) on October 22, 2007 at reel 003643, frame 0818 and reel 03643, frame 0773 and on October 23, 2007 at reel 003644, frame 0603, and (ii) Trademark Security Agreement, executed April 18, 2012 (as amended, restated, amended and restated, modified or supplemented prior to the date hereof, “2012 Trademark Security Agreement”), pursuant to which Debtors granted to Secured Party a security interest in its intellectual property, including the trademarks listed on Schedule A hereto, which was recorded with the USPTO on May 2, 2012 at reel 004770, frame 0163; and

WHEREAS, Debtors and Secured Party are parties to a certain Copyright Security Agreement executed October 19, 2007 (as amended, restated, amended and restated, modified or supplemented prior to the date hereof, “Copyright Security Agreement”) pursuant to which Debtors granted to Secured Party, a security interest in its intellectual property, including the copyrights listed on Schedule B hereto, and which Copyright Security Agreement was recorded with the United States Copyright Office on October 25, 2007 at Volume 3556, Document 492; and

WHEREAS, Debtors have paid off all the loans held by and fulfilled all their respective obligations owed to the Secured Party, and the parties wish to release all Debtors’ intellectual property, including the trademarks listed in Schedule A and the copyrights listed in Schedule B, from any and all security interests held by the Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby terminates, release and discharges its security interest in all of Debtors’ right, title and interest in and to their respective intellectual property and discharges, quit claims and relinquishes unto the Debtors and any party that has rights under such intellectual property (in each case without recourse and without any representation or warranty) any and all rights, title and interest (including, without limitation, any proceeds, goodwill and/or claims) it has in and to such intellectual property, including, without limitation, the trademarks listed in Schedule A and the copyrights listed in Schedule B. The Secured Party authorizes and requests that the Register of Copyrights, and the Commissioner for Trademarks and any other applicable government officer record this Release.
