3. The name of the Company as set forth in its Certificate of Incorporation filed in accordance with the provisions of subsection (b) of §388 of the General Corporation Law of the State of Delaware is UserZoom Technologies, Inc.

The jurisdiction that constituted the seat, siege social, or principal place of business or central administration of the Company, or any other equivalent thereto under applicable law, immediately prior to the filing of this Certificate of Corporate Domestication in accordance with the provisions of §388 of the General Corporation Law of the State of Delaware, is the jurisdiction of Spain.
5. The domestication has been approved in the manner provided for by the document, instrument, agreement or other writing, as the case may be, governing the internal affairs of the Company and the conduct of its business or by the applicable laws of Spain.

The corporate domestication of the Company shall be effective upon the filing of this Certificate of Corporate Domestication and the Certificate of Incorporation in accordance with §388 of the General Corporation Law of the State of Delaware and with the Secretary of State of Delaware.

**CERTIFICATE OF INCORPORATION  
OF  
USERZOOM TECHNOLOGIES, INC.**

**FIRST:** The name of this corporation shall be:  
  
UserZoom Technologies, Inc.

**SECOND:** Its registered office in the State of Delaware is to be located at 3500 South Dupont Highway, Dover, County of Kent, DE 19901. The name of its registered agent at such address is Incorporating Services, Ltd.

**THIRD:** The purpose or purposes of the corporation shall be to carry on any and all business and to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware.

**FOURTH:** The total number of shares of stock which this corporation is authorized to issue is 20,000,000 shares of Common Stock, par value \$0.00001 per share.

The corporation is the successor to USERZOOM TECHNOLOGIES, S.L. ("UserZoom Spain"), a company incorporated under the laws of Spain, which has become domesticated as a Delaware corporation upon the date and time of the filing of this Certificate of Incorporation pursuant to Section 388 of the General Corporation Law of Delaware. Immediately upon the date and time of the filing of this Certificate of Incorporation, each ordinary share of UserZoom Spain shall be exchanged, automatically and without further action, for one share of Common Stock of the corporation. For the avoidance of doubt, upon the date and time of the filing of this Certificate of Incorporation, each holder of record of shares of capital stock of UserZoom Spain shall be deemed to be the holder of record of the shares of capital stock of the corporation issuable upon conversion as provided above, notwithstanding that the certificates representing such shares of capital stock of UserZoom Spain shall not have been surrendered to the corporation or its transfer agent, that notice from the corporation shall not have been received by any holder of record of shares of capital stock of UserZoom Spain, or that the certificates evidencing such shares of capital stock of UserZoom Spain shall not then be actually delivered to such holder; *provided further*, however, that the corporation shall not be obligated to issue certificates evidencing the shares of capital stock of the corporation issuable upon such conversion unless either the certificates evidencing such shares of capital stock of UserZoom Spain are delivered to the corporation or its transfer agent or the holder notifies the corporation or its transfer agent that such certificates have been lost, stolen or destroyed and executes an agreement satisfactory to the corporation to indemnify the corporation from any loss incurred by it in connection with such certificates.
