NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

This is a NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") by VETERINARY SERVICE, INC. ("Assignor"), a California corporation having an address of 4100 Bangs Ave., Modesto, California 95356 to and for the benefit of Huvepharma EOOD ("Assignee"), an Ednolichno Druzhestvo s Ogranichena Otgovornost (EOOD) organized under the laws of Bulgaria having an address of 3A Nikolay Haytov Str., 5<sup>th</sup> Floor, Sofia 1113, Bulgaria.

**Recital**

WHEREAS, Assignor was the owner of all right, title and interest in and to the mark STREPSOL (in all forms in which it has been used), including the following U.S. trademark registration at the U.S. Patent and Trademark Office:

(collectively hereinafter, the "Mark"); and

WHEREAS, effective September 19, 2014 Assignee (at that time known as Huvepharma AD) acquired from Assignor the Mark and certain assets of Assignor pertaining thereto;

WHEREAS, prior to July 22, 2015 Assignee was known as Huvepharma AD, a private joint stock company organized under Bulgarian law, and effective July 22, 2015 Huvepharma AD changed its legal form to become Huvepharma EOOD, an Ednolichno Druzhestvo s Ogranichena Otgovornost (EOOD) organized under Bulgarian law; and

WHEREAS, the parties wish to memorialize in writing the 2014 acquisition of the Mark by Assignee.

NOW, THEREFORE, in consideration of the mutual covenants and agreements of the Parties and for ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

(1) Assignor hereby confirms the assignment, conveyance, and transfer of, and assigns, conveys, and transfers effective *Nunc Pro Tunc* as of September 19, 2014, to Assignee, Assignor's entire right, title and interest in and to the Mark in any and all forms in which it has been used and including any and all common law rights therein, together with the goodwill of the business symbolized by the Mark, and including all trademark applications and registrations for the Mark including U.S. Registration No. 2517360.

(2) Assignor agrees that, at any time, upon the request of Assignee, Assignor will execute and deliver all papers, take all rightful oaths, and do all acts which may be necessary or desirable to secure and maintain protection on the Mark throughout all countries of the world and for vesting title thereto in Assignee, its successors, assigns and legal representatives or nominees, and otherwise to do the necessary to give full effect to and to perfect the rights of the Assignee under this Agreement, including the execution, delivery and procurement of any and all further documents evidencing this Agreement as may be necessary or desirable. Assignee agrees to



reimburse all reasonable expenses incurred by Assignor in taking any actions requested by Assignor under this section of this Agreement.

(3) Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement.

(4) All of the rights, title and interest in and to the Mark sold, transferred, assigned and set over to Assignee hereunder include all income, royalties, damages and payments now or hereafter due or payable with respect thereto, and all causes of action (whether in law or equity) and the right to sue, counterclaim, and recover for the past, present and future infringement of the rights assigned or to be assigned hereunder.

This Assignment is effective *Nunc Pro Tunc* as of September 19, 2014.

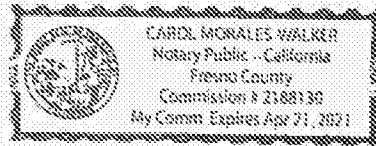
