NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, conveys and assigns to Assignee all of Assignor's right, title and interest, including common law rights associated with the Assigned Mark and applications and registrations thereof, any renewal rights therein, and the exclusive right to enforce the Assignment Trademark in the United States and throughout the world in the sole name of Assignee, its successors and assigns in the United States of America, and in all countries and jurisdictions of the world, in, to and under the Assigned Trademark, together with the goodwill of the business symbolized by and associated with the Trademark, and the right to sue and collect for past infringement thereof. Assignor represents and warrants to Assignee that it is the owner of the Trademark and the associated goodwill and no third party has any right, title or interest in connection therewith. Assignor shall indemnify and hold Assignee harmless from any damage or liability arising from any third party claim that it has an interest in the Trademark or related good will.

GOVERNING LAW, This Assignment shall be governed by, and construed in accordance with the laws of the State of California and the applicable federal laws of the United States of America.
