**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement") dated as of July 25, 2017, from Deutsche Bank National Trust Company, as Collateral Agent (the "Agent") for the benefit of itself, the Trustee and the Noteholders, as defined in the Security Agreement.

WITNESSETH:

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated as of May 27, 2008, made by each of the pledgors signatory thereto (the "Pledgors") in favor of the Agent (the "Security Agreement"), a security interest (the "Security Interest") was granted by each of the Pledgors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 9, 2008, at Reel 3792 and Frame 0537; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Pledgor's right, title and interest of every kind and nature as of the date hereof in the trademark registrations listed on Schedule A hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
