CONFIRMATORY TRADEMARK ASSIGNMENT

THIS CONFIRMATORY ASSIGNMENT is made by, on the one hand, TACTACAM, LLC, formerly a Wisconsin limited liability company, and its members, Randy Hoff and Cassandra Nispe (collectively, ASSIGNORS) and, on the other hand, TACTACAM, LLC, a Wyoming limited liability company having a place of business at 504 West Foltz Drive, Caledonia, Minnesota 55921, and Jeffrey Peel, Tara Peel, Heather Stern and Benjamin Stern (collectively, ASSIGNEES).

WHEREAS, prior to February 2015, ASSIGNORS owned trademark rights, including common law rights, in the mark TACTACAM. Such rights included, but were not limited to, ownership of U.S. Registration No. 4,609,390 for the mark TACTACAM in connection with "Cameras and portable cinematographic cameras for use in hunting; Cameras and portable cinematographic cameras to be used with bow stabilizers" (hereinafter, the "TACTACAM Registration").

On or about February 16, 2015, ASSIGNORS sold, assigned, transferred and set over to the individual ASSIGNEES, on behalf of its TACTACAM, LLC, ASSIGNORS' entire right, title and interest in and to the TACTACAM mark, including but not limited to the TACTACAM Registration, together with the goodwill of the business symbolized thereby. Said trademark rights are to be held and enjoyed by the ASSIGNEES, their successors and assigns as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this assignment not been made.

This Confirmatory Assignment also confirms that the individual ASSIGNEES acknowledge that the acquisition of ASSIGNORS' trademark rights in the mark TACTACAM was on behalf of TACTACAM, LLC, the Wyoming limited liability company. To the extent that any such right, title or interest was not conveyed at the time of transfer, the individual ASSIGNEES hereby assign, transfer and set over any right, title or interest that each may have to TACTACAM, LLC, a Wyoming limited liability company, such assignment, transfer and set over to have been effective as of February 2015.




