STATE OF DELAWARE CERTIFICATE OF MERGER

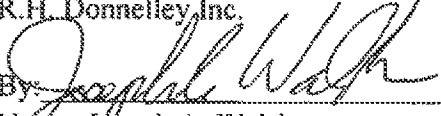
