SECURITY AGREEMENT (SHORT FORM)

This Security Agreement (Short Form) ("Agreement") is made as of July 17, 2017 between Agave Loco LLC, a limited liability company organized and existing under the laws of the State of Illinois, having offices at 1175 Corporate Woods Parkway, Suite 218, Vernon Hills, IL 60061 (the "Grantor") and MUFJ Union Bank, N.A., a national banking association formed under the laws of the United States, having offices at 350 California Street, 10th Floor, San Francisco, CA 94104-1402, (the "Secured Party");
