## GRANT OF SECURITY INTEREST

### TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of July 14, 2017, is executed by **ARC DOCUMENT SOLUTIONS, LLC**, a Texas limited liability company, and **AMERICAN REPROGRAPHICS COMPANY, L.L.C.**, a California limited liability company (each a "Grantor", and collectively the "Grantors"), in favor of **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as the Administrative Agent (in such capacity, the "Administrative Agent") for the financial institutions which are from time to time parties to the Credit Agreement referred to in Recital A below (collectively, the "Lenders").

A. Pursuant to that certain Credit Agreement, dated as of November 20, 2014, as amended by those certain letter agreements dated June 4, 2015, February 5, 2016 and June 24, 2016 and by that certain Amendment to Credit Agreement, dated July 14, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among ARC Documents Solutions, LLC, the Lenders and Administrative Agent, the Lenders have agreed to extend loans and other financial accommodations to ARC Documents Solutions, LLC upon the terms and subject to the conditions set forth therein.

B. Each Grantor has adopted, used and is using the Trademarks (as such term is defined in the Security Agreement, the "Trademarks") described on Schedule 1 annexed hereto and made a part hereof, which Trademarks are registered or subject to an application for registration in the United States Patent and Trademark Office.

C. Each Grantor and other entities party thereto from time to time have entered into a Security Agreement, dated as of November 20, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of the Administrative Agent.

D. Pursuant to the Security Agreement, each Grantor has granted to the Administrative Agent a security interest in all right, title and interest of each Grantor in and to the Trademarks of such Grantor, to secure the prompt payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Each Grantor does hereby further grant to the Administrative Agent a security interest in the Trademarks of such Grantor, including those set forth on Schedule 1 hereto, to secure the prompt payment, performance and observance of the Secured Obligations.

2. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.




