## RELEASE OF SECURITY INTEREST

WHEREAS, **eSentire, Inc.** ("eSentire"), a corporation incorporated under the laws of the Province of Ontario with offices at 278 Pinebush Road, Suite 200, Cambridge, Ontario, N1T 1Z6 is the owner of the trademark registrations and trade mark applications set forth in Exhibit 1, as well as the underlying goodwill of said trademarks (collectively, the "Trademarks");

WHEREAS the Trade Marks are herein referred to as the "Intellectual Property";

WHEREAS, **Comerica Bank**, a bank with offices at 39200 Six Mile Road, Livonia, Michigan 48152 entered into a General Security Agreement and Intellectual Property Security Agreement with eSentire each dated November 29, 2013 (collectively, the "Security Agreements") by which eSentire granted to Comerica Bank a lien and security interest as set forth in the Security Agreements in certain of the Intellectual Property;

WHEREAS notice of the General Security Agreement was filed with the Canadian Intellectual Property Office against certain of the Intellectual Property on January 24, 2014;

WHEREAS notice of the Intellectual Property Security Agreement was filed with the United States Patent and Trademark Office against certain of the Intellectual Property on January 22, 2014 at Reel 5198, Frame 0300;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Comerica Bank hereby releases and discharges all security interest, lien and other encumbrance granted to it in the Intellectual Property including, without limitation, under the Security Agreements.
2. To the extent Comerica Bank retains any such interest, Comerica Bank hereby assigns, transfers and conveys to eSentire all of Comerica Bank's rights, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Intellectual Property. Such assignment, transfer and conveyance by Comerica Bank is made without any representation or warranty (express or implied) by Comerica Bank.
3. Comerica Bank hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release of Security Interest, all at the expense of eSentire.
4. This Release of Security Interest shall be binding upon and enure to the benefit of the respective successors and assigns of the parties hereto.
